**2. Payments: \$700** for any horse nominated to all five Ohio Sires Stakes legs. \$200 for any horse nominated to a single Ohio Sires Stakes leg. \$500 is the entry fee for each Ohio Sires Stakes leg.

There are no sustaining payments. For each across-the-board nomination, \$100 will go to each series race and \$200 to the Championship. On individual race payments, the entire \$200 payment will go to the series race. All nominating and entry fees must be paid in U.S. currency. A horse entered by a nominator who pays fees with a dishonored check may be dropped from the eligibility list and the matter may be referred to the Ohio State Racing Commission under Ohio Administrative Rule 3769-17-42.

- **3. Entries:** Starters in legs and Championships shall enter at the regular time practiced at that racetrack. Each race is a one-mile dash. There will be a six-hour detention time for the 2-year-old and 3-year-old Championships and any single race with a purse of \$100,000 and over. Any horse late for detention shall be scratched by the judges.

Entry Fee for Gray Championship is \$500. The non-purse earning finishers in the \$100,000 Gray Championships (6th through 9th on a five-eighths or 6th through 8th on a halfmile) that start and finish the race, will receive a \$1,000 starter's payment.

Points will be awarded in each of the first five legs of the series as follows: Win-51, Second-26, Third-13, Fourth-9, Fifth-6, and all remaining starters-1. In the event of a dead heat, horses shall receive the standard distribution of points for their particular order of finish. For the purposes of awarding points to qualify for the Championships, each leg's division shall be considered a race.

When the Scarlet and Gray Championship or Scarlet Championship is raced on a half-mile track, the eight horses with the highest point totals are not eligible to race in the Gray

Championship. - 1. Entry Fee: Nominations are not required. The entry fee for each Veteran Championship is \$500. Veteran Championships are for 4-year-olds and up, trotting horses or geldings, trotting mares, pacing horses or geldings, and pacing mares. If six separate betting interests are not entered for any Veteran Championship, that Veteran Championship may be canceled or combined as the host track Racing Secretary sees fit.
- 2. Eligibility: Four-year-olds and up, trotters and pacers who are sired by a stallion registered with the Ohio State Racing Commission (OSRC) during year of conception. Any foal produced by embryo/ovum transplant shall be eligible when in compliance with the United States Trotting Association (USTA) Rule Number 26.24.

Eligibility of starters in each of the Veteran Championships are restricted to the eight (on a half-mile track) and nine (on a five-eighths mile track) leading money winners in races conducted at Ohio commercial tracks and Ohio fairs from January 1, 2025, and prior to the day before each respective race's draw, who have raced a minimum of five times in Ohio in 2025 will be given first preference. Leading money winners in races conducted at Ohio commercial tracks and Ohio fairs from January 1, 2025, and prior to the day before each respective race's draw, who have raced a minimum of four times in Ohio in 2025 will be given second preference. If the race doesn't fill after application of the second preference, the race may be re-opened to continue to add horses that have raced in Ohio for fewer than four starts. Horses with a higher number of Ohio starts will be in under this section with entry re-opened to fill the remainder of the field with lower preference eligible horses, except that all eligible horses that met the higher Ohio preference condition and were declared into that race prior to and after the re-opening, shall automatically be drawn into the race. If two or more horses tied in earnings declare in under any preference in the Veteran Championships, the horse with the highest Ohio earnings for the current year will be a starter. If the tie is not broken by earnings when getting to the last entry, the final starter shall be drawn by lot. All horses' earnings will be verified by examination of the official records of the United States Trotting Association (USTA). Purse earnings in other jurisdictions do not count toward a horse's Veteran Championship eligibility.

- **3. Requirements to Start:** At time of entry, a starter must show, within 45 days prior to the advertised day of the race, at least one performance line without a break and within the qualifying time requirements at the host track. An official workout before the Judges will not be acceptable.
- **4. Purses:** All entry fees will be added to each Veteran Championship. No funds for a Veteran Championship shall be allocated to or paid to a permit holder by the Ohio Standardbred Development Fund (OSDF) unless the permit holder adds at least twenty-five (25%) percent to the amount allocated by the OSDF to each Veteran Championship. Purse distribution for each Veteran Championship shall be: 50%, 25%, 12%, 8%, 5%.
- **5. Starters:** All Ohio Sires Stakes must be scheduled as betting races unless approved by the OSDF. If fewer than five horses enter, the race may be raced as a non-betting race with the approval of the Ohio State Racing Commission.
- 6. Starting: If two or more horses tied in earnings declare in for the eighth position on a half-mile track or ninth position on a five-eighths-mile track, in any Veteran Championship, the last starter shall be drawn by lot. Two also-eligible horses may be drawn, and the same method used in the case of a tie. An also-eligible horse may move into a Veteran Championship if a scratch occurs prior to the designated scratch time at the host track. Starters in Veteran Championships shall declare in at the usual time for overnight entries practiced at the host track. Any horse scratched sick or lame from any purse race shall not race in a Veteran Championship unless seven days have passed from the date of the race from which the horse was scratched.
- **7. Cancellations:** If circumstances prevent racing any Veteran Championship at the scheduled track on its advertised date, the OSDF may reschedule the race on another date or another track, whenever possible.
- **8. Rules:** Unless otherwise specifically stated in the conditions, Ohio State Racing Commission Rules will govern. The interpretation of any of the conditions and settlement of any disputes that arise will be determined by the OSDF in their sole and complete discretion in making a final decision. The Ohio State Racing Commission reserves the sole and exclusive right to modify, alter, amend and/or cancel any event in its entirety. Each Veteran Championship is a one-mile dash.

   Nomination and Entry Fees are due upon entry and are non-refundable.
- Eligibility to only those foals sired by a Standardbred stallion registered with the Ohio State Racing Commission during the year of conception. Horses must be registered with the United States Trotting Association before nomination.
- Entering or Starting a horse in the same Leg of the Buckeye Stallion Series (BSS) and the Ohio Sires Stakes (OSS) is prohibited. Entering a horse that has raced in the same Leg in the Ohio Sires Stakes will result in a scratch from the Buckeye Stallion Series. - All ineligible, invalidated, and annulled horses are ineligible for the Buckeye Stallion Series Consolation and Buckeye Stallion Series Final.
- Entries or Starters in the BSS that did not pay any or all monies required under the conditions shall be disqualified, placed last, and all monies, purse, or points are forfeits.

In the event of a dead-heat, as with purse money division, horses shall receive the standard distribution of points for their particular-order of finish.
- Points shall be awarded according to any placing of the judges. Any pending appeal of a ruling issued by the judges shall not alter the placing determined by the judges. Participants with appeals yet to be decided at the time of declaration for the Ohio Fairs Championship will have points deducted for the violation. In the case of a positive drug test, all appeals will have points deducted for a placing, unless the case has a final, unappealable decision prior to declaration for the Ohio Fairs Championship.
- Should any participant in the OFRC be notified of a positive drug test result in any OFRC Race, he/she must notify the OHHA upon receipt of the notice.
- If a no contest is declared in any Ohio Fairs Fund race, all purse money is evenly divided, and fifteen (15) points are awarded to all non-offending horses not scratched before the no contest that start the race.
- Cancellations. If circumstances prevent racing any leg at the scheduled racetrack on its advertised date, the OHHA may reschedule it on another date or at another track.
- Unless otherwise specifically stated in the OFRC conditions, OSRC Rules will govern. The interpretation of any of the conditions and settlement of any disputes that arise will be determined by the OHHA in their sole and complete discretion in making a final decision. The OHHA reserves the sole and exclusive right to modify, alter, amend, and/or cancel this event in its entirety.

Horsemen will make a one-time payment of \$700.00 Per horse and be able to enter whatever fairs you desire at time of declaration. There will be no other payments for your horse.

- If you wish to enter only one (1) and no more than three (3) fairs you may do so by paying \$100.00 per fair and then no starting fee at time of entry. You must name these fairs at this time and this cannot be changed.

Two and three-year-olds must have at least one day in between race days at the time of entry. <u>MEMBERSHIPS:</u> All registered owners at time of submission of each colt or filly must be a member of the O.C.R.A. to make a nomination. Memberships are per person and not per horse (an owner may have several horses but only needs to pay the membership fee once). The \$35.00 fee is due and payable for <u>each</u> registered owner of the horse as shown at the USTA when making the nomination payment by **MARCH 15, 2025** 

ASSOCIATE MEMBERSHIPS: For non-owners such as grooms, family members or friends of racing are available at \$20.00 each.

<u>FAIR PASSES</u>: One membership card (fair pass) will be mailed in May for each membership and associate membership which has been paid. Cards will admit one person to the fairs on race day. This will be a universal pass for all circuits in the Buckeye Fair Racing Consortium (44 fairs). Unless otherwise directed, the passes will be mailed to the person who paid.

<u>DECLARATIONS</u>: close at 10:00 A.M. THREE (3) DAYS before the race, unless listed differently under a fair's conditions in the Huff's Guide. Two and Three-year-olds must have at least one day in between race days at the time of entry. **STARTING FEE:** \$100.00 payment is due and payable the day of race, even if the horse is scratched. In the event more than 8 horses are declared in to start, the race shall be divided and raced in divisions with no more than 2 trailers. Each division will race for an equal share of the total purse. The Judge may alter the division of the race in any way, taking into consideration track safety. OSRC/USTA Rules to govern all races.

**PURSE DISTRIBUTION:** The purse for each race will be divided as follows:

5 or more to start:  $50^{\circ}$ -25 $^{\circ}$ -12%-8%-5% 4 to start: 55%-25%-12%-8% 3 to start: 60%-28%-12% 2 to start: 65%-35% 1 to start 100% and the horse must start and go over the course. Purse checks will be made payable only to the first programmed owner at declaration. That owner will be financially responsible for purse money and subsequent distribution to any other owners.

**TROPHIES:** Awarded at the annual banquet to owners of colts and fillies having the most points in each class based on the following system: Win-51, Second-26, Third-13, Fourth-9, Fifth-6 and all remaining starters-1. - Entry Fee \$75 due and payable at time of declaration.

If any condition, beyond the control of the Association arises which prevents the racing of these stakes, or any division thereof, the right is reserved to call same off and pay the persons owning the colts/fillies on the grounds eligible at the time of said calling off, their pro-rata share of all money which has accrued in the division or division called off, after deducting the actual expenses of the Association. Rules of the OSRC/USTA go govern except were modified.


